- 6. You understand that the research project may, at any time, be slightly modified by mutual consent of the research investigators, without changing the focal point of the research theme.
- 7. You acknowledge by completing and signing the *Authorship agreement form* that the order of the authorship is a collective and mutual understanding between the co-authors, and that authorship credit is based on substantial intellectual contribution, established by the International Committee of Medical Journals Editors (ICMJE).
- 8. If major disputes arise and cannot be resolved by the principal investigator (or it involves the principal investigator with the collaborators), the dispute is arbitrated by a third party; in this case, it is the head of the LHRC or even the executive director of the Health Sciences Research Center (HSRC). The decision of the head of the HSRC or the executive director of the HSRC is final.
- **9.** You agree on the confidentiality of the research findings until they are published or presented in a conference by a member of the research team.
